Adoption Contract

This contract is made by and between adopter _____ and Praying for Paws, Inc (hereafter know as PfP). This contract is specifically regarding the Praying for Paws dog named _____.

1. Praying for Paws (PfP) agrees to provide all medical records that were obtained on said dog during the dog's time in the PfP program. Other than the attached medical records, PfP makes no representations regarding said animal's health.
2. The adopter shall provide the dog with humane care and health maintenance According to municipal, county, state and federal laws. In addition, the adopter Shall treat the dog with dignity and respect and as a member of the family.
3. The adopter shall provide the animal with necessary veterinary care on occasion Sickness or injury. In addition, the adopter shall have the dog examined by a veterinarian on at least a once yearly basis.
4. The adopter shall provide monthly heartworm preventative and flea and tick Prevention.
5. The adopter will not at any time place the animal outdoors for an entire day and Will not leave the animal chained or tethered for more than 4 hours. In addition, The dog will be allowed to sleep and reside indoors. The adopter agrees to feed, water and exercise the animal on a daily basis and additionally as needed.
6. The adopter agrees not to leave a choke collar on an animal unattended or to leave The animal tethered to a chain that might result in entanglement.
7. The adopter will ensure that the animal is wearing a collar and rabies /identification tags at all times.
8. The animal will not be housed exclusively in the basement or garage.
9. The adopter agrees that the adoption fee becomes a non-refundable donation after The contract is signed. In addition, the adopter agrees to indemnify Praying for Paws from any and all claims, known or unknown, now or hereafter arising In connection with said animal.

10. The adopter agrees to provide information on the adoptive animal's veterinarian
And the animal's status in the new home following adoption. In addition, the
adopter is hereby informed that PfP can reclaim said animal
If conditions of this contract are not followed.

11. The adopter agrees to pay for any and all attorneys costs and court fees if PfP
needs to utilize the court system to enforce this contract.
